The 2010 Annual Patron Drive has ended and through the generosity of our members and contributors, AAJ raised a sum of nearly \$5,000 and has maintained its non-profit status. Marianne graciously gives of her time to write letters, make calls and do whatever is necessary to raise funds for the continuance of our organization. In May, AAJ conducted its' annual Scholarship Awards Program. Under the direction of our scholarship coordinator Lida Hood and this year's judge, Assistant Professor of Art Ivan Fortushniak (I.U.P.), over \$3,000 in scholarship money was awarded to six seniors who will pursue art related studies: Haley Schott - Meyersdale, Tiffany Parsons and Sara Mihelic - Richland, Alexandra Mundy - Westmont Hilltop, Sarah Oldham - Windber, and Amanda Shultz - Bishop McCort. AAJ's 78th Annual Fall Exhibit will open on September 17th at Southern Alleghenies Museum of Art at Johnstown. The exhibit will remain on display through January 7th, 2011. The opening reception and awards ceremony will be held on September 24th from 6:00 to 8:00 PM in the SAMA Johnstown Gallery. Pieces by Harriett Goff and Mark Parrish will be included in the exhibition to pay tribute to these members who have passed away in 2010. Also included will be a piece by member Elsie Krissay, who is receiving a Life Membership Acknowledgement, bestowed upon any individual who has remained a member for 50 years or more. Ms. Krissay will celebrate her 103rd birthday in November. Congratulations Elsie!
