JUROR: Michael Allison has been working in various capacities as a visual artist in central Pennsylvania for the past thirty years. His business STUDIO EFX has provided design and Fabrication services to a variety of clients. He was the curator at Southern Alleghenies Museum of Art from 1980 to 1989. ENTRIES: Members and non-members may enter one to three pieces for a flat fee of \$15. Membership dues must be paid in advance or on the day of receiving. Non-members are eligible to enter the Spring Exhibition; however, they will be charged an additional \$25 membership fee. The total charges for non-member entry to the Spring Exhibit will be \$40 for one to three pieces. Please have exact amount or check payable to ALLIED ARTISTS at the time of entry. If a non-member's work is not accepted into the exhibit, the additional \$25 membership fee will be returned. Only one NFS (not for sale) work may be entered per artist, per show. Subject matter should be suitable for public display.

EXHIBITING OF WORKS: Art work which has been previously accepted and displayed in any Allied Artists exhibition cannot be entered and shown again. Submitted works must be original; no work done under instruction or "study of" or utilizing copyrighted works or images are permitted. These guidelines have been established to encourage the creation and continued production of fresh and original works of art. All work must be properly framed and ready to hang and display. No saw-tooth hangers will be accepted.

LIMITATIONS: Oversized work exceeding 4 feet in any direction is not appropriate for shows at AmeriServ Bank. Free standing 3D sculpture will no longer be allowed by the bank. Wall-hung relief sculpture is permitted. AmeriServ reserves the right to remove anything that they consider "offensive or inappropriate". Though care is exercised in handling works, AAJ does not assume responsibility for damage or loss. The artist shall understand that submission of art constitutes an agreement with the conditions set forth herein and considers this application a commitment to show.

SELECTION OF ART WORK FOR EXHIBITION: For any juried exhibition, the art work selected to be displayed is solely the decision of the juror. In addition, he/she will ultimately decide who will be accepted as a new member of Allied Artists by choosing the individual's art work for inclusion in the exhibit.

SALE OF ART: Any work sold during the exhibition will be divided as follows: 80% to the artist, 20% to AAJ. Please be sure to price work accordingly.

Entry Forms: The attached entry form must be completed in DUPLICATE FOR EACH WORK entered into the Show. Attach one copy securely to the reverse side (or bottom for 3-D works) of each work and submit the second copy of the entry form to the Allied Artists staff with your entry fee at receiving.
