

51st Annual Spring Show of the Allied Artists of Johnstown, Pennsylvania

Location: Ameriserv Financial, corner of main and Franklin Streets, Johnstown. Please use Franklin Street Entrance.

Receiving: Saturday, April 10th from 10:00 am to Noon. Works not selected can be picked up from 1:00 to 2:00 at Ameriserv.

Public Opening Reception: Friday, April 16th from 6:00 to 8:00pm at Ameriserv.

Show Pick Up: Saturday, May 1 from 10:00 to Noon.

Entries: One to three pieces for a flat fee of \$15.00 for members (non-members will pay an additional membership fee of \$15.00. If work is accepted for the show you will be eligible for a one year membership to Allied Artists of Johnstown at no additional cost. If non-member work is not accepted, there will be a \$15.00 refund.) Please have correct change. Allied Artist's members' dues must be paid prior to receiving. Work must not have been shown in previous AAJ exhibit or within a 30 mile radius.

NFS: Only one NFS per artist. Any artist selling work is expected to contribute 20% of the selling price to Allied Artists of Johnstown.

This Spring Show is a juried exhibition open to all artists or photographers over the age of 18. Submitted pieces should be ready to hang (saw-tooth hangers will not be accepted). Oversized work is not appropriate for this show. Work larger than 36 inches will be considered oversized. Space is limited for 3-dimensional work.

All artwork is exhibited at the artist's risk; small items should be properly secured. Subject matter should be suitable for public display. The juror will make final decision.
